Legal Defence

Due to a highway closure, Kathy is charged with driving over the maximum number of hours allowed in a 24-hour period. **ARAG will assign a lawyer and pay legal costs to defend the charge.**



Legal Defence

(Optional U.S. & Mexico Territorial Limit Extension)

Darren received a ticket for the unauthorized use of a restricted vehicle on a U.S. interstate highway, as he was operating his truck outside of his permit area. He proceeded to hire a lawyer within the state where he was charged. **ARAG will reimburse Darren for his legal bills up to \$10,000 USD.**



Contract Disputes

Rina, a small business owner, purchased a delivery van for her company and later discovered that the van had been involved in a previous accident. This information had not been disclosed to Rina, and the dealer refused to accept a return. **ARAG will assign a lawyer to pursue the dealer and negotiate a return.**



Statutory Licence Protection

A business is assigned a conditional safety rating following a failed facility audit. The business has since fixed the issue that resulted in the failed audit, but the Ministry refuses to amend the conditional rating at renewal time. **ARAG will assign a lawyer, cover legal fees to defend the business and appeal the decision.**



Driver's License Protection

Yang received a ticket that resulted in his commercial driver's license being suspended. His business activities require him to drive. **ARAG will appoint a lawyer and cover legal fees to appeal the decision.**
